An introduction into special education law, the intent and objectives are for the attendee to gain a general understanding of the Federal and state laws as they pertain to Kansas Students with disabilities. Special education law in Kansas ensures that children with disabilities receive a free and appropriate public education (FAPE) tailored to their individual needs. Governed by both federal laws like the Individuals with Disabilities Education Act (IDEA) and state-specific regulations, Kansas guarantees access to services for students with disabilities from birth to age 21

There are many reasons why mediations may stall or fail. By learning how cognitive and personality factors affect decision makers, mediators can adapt and adopt techniques to minimize these obstacles. You will learn the primary types of "mental mistakes" that complicate rational decision making and strategies to aid the parties in setting those aside "or working around them ". There will also be an opportunity to review basic personality types and how they manage conflict. Strategies will be suggested to assist the parties where these are present.
