9:00 am to 9:50 am INTERSECTION OF SPECIAL EDUCATION LAW AND FAMILY

(Matt Rogers and Bethany Roberts)

Parents struggle to navigate the special education process for their children. When the parents do not agree, the issues become even more difficult. This session will examine the intersection between federal and Kansas special education law and Kansas family law, such as the IDEA's statutory language and federal court decisions that define a "parent" for purposes of exercising parental rights under the IDEA and the importance of Kansas family law in determining who is a parent for exercising IDEA's rights. The presenters will offer common, concrete examples and proposed solutions both for moving forward both in the custody courts and in the special education process

Bethany Roberts is the Managing Member with Barber Emerson, L.C. in Lawrence, Kansas, where she acts as a guardian ad litem, conciliator, case manager, and mediator in high-conflict domestic cases. Previously, Ms. Roberts served as the Pro Tem juvenile judge in Douglas County, where she handled a high-volume caseload of juvenile offender and child in need of care cases. Ms. Roberts is proud of her many years at Kansas Legal Services in Topeka, Kansas, where she served as the Managing Attorney and specialized in representing survivors of all ages who had experienced domestic, sexual, stalking, and dating violence. Ms. Roberts is also an adjunct professor at the University of Kansas School of Law, Ms. Roberts previously worked as an elementary-school teacher. Go Jayhawks!

Matthew J. Rogers, Esq., is a partner with the law offices of Barber Emerson LC in Lawrence, Kansas. This presentation will discuss supported decision-making agreements, powers of attorney, and guardianship and conservatorship orders as options to facilitate decision-making when youth with disabilities turn eighteen. The presentation will include an overview of when each tool is appropriate and how parents and caregivers can work with medical providers to assess a youth's capacity.

Michelle Ewert is a professor at Washburn University School of Law and Director of the Washburn Law Clinic. Planning for incapacity and empowering people with disabilities are areas of focus for her clinic section. Prior to starting clinical law teaching, she was a legal services attorney in California, Illinois, and Maryland. Michelle received her J.D. from the University of Wisconsin and her Master of Public Policy from the University of Minnesota.

Prior to earning a law degree, she worked as a school social worker and other foster care and child advocate roles, including as a CASA volunteer. Kerrie earned a Bachelor of Social Work from the University of Kansas, a Master of Social Work from Washburn University, and is a graduate of Washburn University School of Law. During her tenure in public service, Kerrie has served on numerous statewide panels and workgroups for child and family well-being system improvement.

(Presented by Dr. Bud Dale)

Advocates for children to have a "voice" in legal matters have become increasingly successful at findings ways for the child to be heard. This session will review interview strategies for learning the child's perspective, educating the child on the legal process, and getting information that will help the court make a "best interests" decision.

This session will focus on the myriads of ways the mediator can assist parents to meet the individual needs of their specific child(ren) with a parenting plan that is regular, consistent, and know-able to their child(ren). The litigator has the opportunity to either: villainize the other parent—or--work their tail off to find a solution that recognizes a child's right to love and enjoy safe and appropriate access to both parents.

Carly Boothe graduated from KU Law, served as a domestic violence prosecutor and then transitioned to the family law arena. After more than a decade of litigating, Carly discovered the opportunity that mediation brings to families going through this transition. Carly's practice is now wholly centered on mediation, but she occasionally is guilted into serving as a Parent Coordinator or Case Manager in cases where the family court requests intervention

In this ethics presentation we will cover Kansas and Missouri ethical considerations as well as highlighting some professional responsibility dilemmas faced by the attorneys in the television series *Suits. Some highlighted ethical rules to be discussed are: 4.1 Truthfulness in Statements to Others, 8.1 Bar Admission and Disciplinary Matters, 1.1 Competence, 5.5 Unauthorized Practice of Law, 8.3 Reporting Professional Misconduct, 5.3 Law Firms and Associations: Responsibilities Regarding Nonlawyer Assistance, 8.4 Misconduct.
